*RECOMMENDATION COMMENTS:

INMATE JOHNSON, KEVIN DC#158039 IS BEING RECOMMENDED FOR CMI. INMATE JOHNSON WAS RECEIVED AS AN INTERSTATE COMPACT FROM VIRGINIA DUE TO BEING A MANAGEMENT PROBLEM AND SECURITY RISK. INMATE JOHNSON IS A SELF-PROCLAIMED STG LEADER AND MEMBER OF THE "NEW AFRIKAN BLACK PANTHER PARTY" (PRISON CHAPTER) WITH A RANK OF MINISTER OF DEFENSE AND A PRISONER ORGANIZER AND REVOLUTIONARY COMMUNIST. INMATE JOHNSON WAS FIRST TRANSFERRED FROM VIRGINIA TO OREGON ON FEBRUARY 11, 2012 AS AN ADMINISTRATIVE MANAGEMENT CASE. WHILE IN OREGON HE RECEIVED 6 DISCIPLINARY INFRACTIONS. HE ALSO WAS ABLE TO CREATE AN ONLINE WEBSITE AND RECEIVED MANY FOLLOWERS THAT BOMBARDED OREGON DOC WITH PHONE CALLS WITH THE ALLEGED TREATMENT INMATE JOHNSON WAS RECEIVING. INMATE JOHNSON WAS TRANSFERRED FROM OREGON TO TEXAS ON JUNE 14, 2013 FOR CONTINUING TO BE A MANAGEMENT PROBLEM. WHILE IN TEXAS DOC HE RECEIVED 17 DISCIPLINARY INFRACTIONS AND HE CONTINUED TO RECEIVE FOLLOWERS ON HIS ONLINE WEBSITE THAT CAUSED DISRUPTION IN THE ORDERLY OPERATIONS OF THE INSTITUTION. AS A RESULT OF HIS ORGANIZING AND HIS AFFILIATION WITH THIS GANG HE HAS BEEN TRANSFERRED TO SEVERAL STATES DUE TO HIS ONGOING STG ACTIVITIES. DURING HIS INCARCERATION AT RMC THE WEBSITE HAS CONTINUOUSLY BEEN UPDATED TO INCLUDE CONFIDENTIAL INFORMATION SUCH AS HIS LOCATION, DC NUMBER, AND CONTACT INFORMATION FOR THE INTERSTATE COMPACT OFFICE FOR THE STATE OF VIRGINIA. THE MOST RECENT POSTING IMPLORES COMMUNICATION FROM THE PUBLIC TO THE ICC OF THE STATE OF VIRGINIA FOR HIS IMMEDIATE RETURN. BASED UPON THESE FACTS IT IS RECOMMENDED HE BE PLACED ON CMI TO MAINTAIN THE SECURITY AND ORDERLY OPERATIONS OF THE INSTITUTION.
