ISAAC Logan #W23317 Cell #B1214, I've been house in this cell since November 21st, 2017 and my window dose not close or has large drafts that cause the cold air to the outside to blow into my cell especially when the exhaust fans are on, which the wing officers stay with them on all the time. And my cell stay extremely cold because of this and as cold as the temperature outside and the officers has the knowledge of the cell windows in most cells. The exhaust fans should not be on every day all night long. The temperature of the cold be below 30° degrees. And i've observed Mr. Lt. Thompson placing inmates on strips cells consistently and fully aware of the cold temperature. And knowing most of the cells windows like mine putting us inmates on strip cells with out sheets, clothes, blankets ect. Is of for mental and physical torture to us inmates. Being on cell strip with out having the means to warm materials were left to embrace the temperature of the outside cold. Shivering with running nose because of being on strip suppose to be prohibitive throw out the Department of Corrections but (Yes) Florida State Prison still doing it. The Lt. and OIC has Mental Health and Medical Staff down with these things they dont suppose to be doing. And theyll lie saying you got your cell window cover up because the hall camera could not see the cell doors to prove they lying.

I, Eduardo Vargas, DO# L01184, do hereby swear that the following statement is true and correct and made of my own free will and from my own personal knowledge:

I've been housed in cell B1219 since January 9th, 2018. I was first placed in this cell on "strip," which is another name for property restriction. Before entering this cell, an inmate yelled out that the window in this cell is was broken, so I then informed Lt. Knight and Cpt. Box that the cell window was broken. They had shrugged their shoulders and told me to enter the cell, to which I complied.

Not long after, a cold-front came in that included sub-freezing weather every night. It was so cold in my cell that I could see my breath when breathing. I had no mat, so I was forced to sleep on the frozen steel slab of my bunk in just my boxers and without covering. I had curled up into a ball just to keep warm, but this was ineffective- I could not stop shivering. I then tried to close my window all the way and seal the cracks and crevices of my window with wet toilet paper, but none of this worked. With the air from outside being sucked violently into my cell by the exhaust fans, the wind chill created a lower temperature in my cell than was outside.

Even when I had received clothing and linen three days later, I was still shivering. One layer of clothing ^{just does} ~~and more~~ not suffice, and this is why one can see the officers walking around in jackets, gloves, and thick skull caps. The heater does not work, and when we do write this up we receive a response that says that the heaters do work.

Knowing that our windows don't close all the way, that there are many cracks and crevices in and around our window, and that the heaters don't work, Lt. Thompson takes advantage of this. Almost every day he puts ^{several} people on property restriction. Everytime he lies by saying that we are misusing our property by having it on the floor or on the back window. He then demands that we give up our property. If we don't give up our property, we are then sprayed with O.C. and C.S. gas, and our property is taken anyway. And when we do try to write up this abuse, the grievance is never processed. For example, I had put an emergency grievance in the grievance box on the 16th of January, 2018, called my cell number out so that the audio could witness that it was indeed I who put the grievance in the box, and then waited to receive my receipt at mail-call. I never received one, nor have I received a response. And many others have experienced the same.

I, Emanuel Joe Edwards do hereby swear that the following statement

is true and correct and made of my own free will and from my personal knowledge,

I, Inmate Emanuel Edwards DO#E37896, has been here at Florida State Prison / Main Unit, in "B-wing (Bravo), cell - 1216^{single}" since "10-19-17". It has been an "on-going" issue, for awhile, with the windows not properly closing, which causes the temperature inside the building to drop to a freezing point, especially when the "exhaust fans" are continuously kept on, thru-out the days and nights, when we are still in the winter stages.

Florida has also been experiencing freeze warnings, from "cold fronts" and we have no heaters working in the wing at all.

Staff treats us differently here, on "DC" status, in giving us proper clothing materials, to keep warm, so majority of the times, when we experience "freeze warnings", we have nothing to properly prevent us from experiencing "hypothermia".

Officers here at "Florida State Prison / Main Unit" makes it a retaliation tactic, to place inmates on "property restriction", for reasons that don't apply, as enforced by "FDAC (ch.33)", just for inmates who may have "psychological emergencies" and yells to the wing staff, to inform them of their emergencies. Wing staff then calls the assistant shift (AC) Stephen Thompson and has the inmate placed with nothing inside their cell.

HOWEVER MY CELL WINDOW DOES NOT CLOSE AND HAS LARGE DRAFTS THAT CAUSE COLD OUTSIDE AIR TO COME INTO THE CELL, ESPECIALLY WHEN THE EXHAUST FAN IS ON. MAKES THIS CELL MORE COLD. WHICH MAKE THIS CELL FEEL THE SAME AS OUTSIDE: "ICE BOX". ALSO I HAVE EXPLAIN TO OFFICER WHO WORK THIS WING (B) THAT I CANT KEEP WARM NO MATTER. BECAUSE MY PERSONAL CLOTHES ARE STORAGE INSIDE PROPERTY, AS ITEM "SWEATER", "LONGJOHNS TOP & BOTTOM". WHICH I'M ONLY PROVIDED WITH PANTS, SHIRT, SOCKS, AND A UNDER SHIRT, AND ONLY A EXTRA BLANKET, WHICH DOES NOT HELP WITH THIS WINDOW NOT CLOSING CAUSE ME TO BE VERY ^{COLD} AND THATS INSIDE CONFINEMENT UNIT.

HOWEVER THE HEAT IS NEVER ON IN THE WING AND EVEN IF IT WAS THE AIR COMING IN THE WINDOW WOULD OVER POWER IT.
